There is an optional practice on Friday, March 31. You do NOT need to attend this practice session. Saturday, April 1 will be practice, heats, and the 50-lap feature.

RIMS: 7" or 8" rims allowed.

TIRES: HOOSIER 790 tire only. NO CHEMICAL TREATING.

TREAD WIDTH: Maximum 72.5" measured from outside to outside of wheel bead.

RIDE HEIGHT: 5" minimum chassis height.

SPOILER: 5" x 60" maximum.

CLUTCH: Stock-appearing 10.5" flywheel and pressure plate only. NO MULTI-DISC.

LEFT-SIDE WEIGHT: 55% maximum.

SHOCKS: \$110 Maximum cost.

BODIES: Street Stock-type only. No Late Model ABC bodies and no Outlaw wedge-style bodies.
